- What is the best account of sentences like "Galileo said that the earth moves"? (2000, 9)
- What account of their meanings best explains the difference between "Jones said that someone murdered Smith" and "There is someone of whom Jones said that he murdered Smith"? (2001, 18)
- How is the meaning of "John hopes that P" related to the meaning of "P"? (2002, 13)
- To what, if anything, do terms in indirect discourse refer? (2003, 16)
- Does the name "Venus" have its customary reference in the sentence "John believes that Tony said that there is life on Venus"? If not, to what, if anything, does it refer? (2004, 14)
- Does the proper name "Cicero" have the same semantic role in the sentences "Cicero is an orator" and "Alice believes that Cicero is an orator"? (2009, 8)
- Do belief reports pose a problem for the principle that the meaning of a sentence is a function of the meaning of its constituents? (2011, 1)
